

Sustainable Construction material used in Green building

The Rockefeller Block at Chitkara University stands as a beacon of sustainable construction, adhering to the highest standards of environmental responsibility as prescribed by the IGBC New Building Standards. With a firm commitment to minimizing embedded carbon, all building materials used in this state-of-the-art structure were carefully sourced from within a 400-kilometer radius. This deliberate choice ensures a reduced carbon footprint, minimizing the environmental impact of transportation and promoting the use of regional resources.

In line with the green building objectives, the materials chosen for construction are eco-friendly and fully compliant with the IGBC's stringent guidelines. The building features:

1. **Eco-Friendly Refrigerants:** All cooling systems employ eco-friendly refrigerants that do not contribute to ozone depletion, ensuring the Rockefeller Block is free from ozone-depleting substances.
2. **Low Emitting Materials:** To promote indoor air quality, only low-emitting materials were selected for use in paints, adhesives, and flooring. This significantly reduces harmful emissions such as volatile organic compounds (VOCs), contributing to a healthier indoor environment.
3. **CO₂ Monitoring:** The building is equipped with advanced CO₂ monitoring systems to maintain optimal indoor air quality, ensuring that carbon dioxide levels are continuously monitored and managed for the well-being of its occupants.
4. **Sustainable Materials:** A significant portion of materials used in the Rockefeller Block contains recycled content, further reducing the demand for virgin resources and promoting the use of sustainable, eco-friendly products.

By adhering to these standards, the Rockefeller Block exemplifies the values of sustainable construction, not only in the materials used but also in its operations and maintenance, setting a new benchmark for green buildings in the region. This approach aligns with Chitkara University's commitment to environmental stewardship and sustainable growth, further enhancing its status as a leader in responsible development.
