Memorandum of Understanding (MoU)

Between Litvill Lessons Association And Chitkara University

Date: 21 April 2025

This Memorandum of Understanding (MoU) outlines the collaboration between Litvill Lessons Association (hereafter "LLA") having its registered address at 67,Goshal Road Sanganer, Shiv Vatika, Bagru Jaipur, Jaipur, Rajasthan-303007 and

Chitkara University (hereafter "the CU") having its Corporate Office at Chitkara University Campus, Chandigarh- Patiala National Highway, Village Jhansla, Rajpura, Punjab-140401 for 1 Year educational initiative focused on Survival skills for 20-30 students in India.

1. Purpose

The purpose of this MoU is to jointly conduct a short-term Non-credit based program that equips selected Indian youth with knowledge and skills in sustainability, and personal development.

2. Roles and Responsibilities

The University agrees to:

- Provide qualified faculty/mentors to guide students for a period of 1 year.
- Weekly one hour webinar by faculty members.
- Mutual display of branding on our platforms.
- Provide co-branded certificates to learners.
- Explore opportunities for an academic publication.

Litvill agrees to:

- Provide the full educational content and program structure (access to LMS).
- Share student progress reports and participation data.
- Offer co-branded certificates to all students who complete the program.
- Acknowledge the University's contribution in all public and internal reports related to the program (e.g., Website, social media platforms, other forms of non-academic publications).





3. Branding and Certificates

Both parties agree to co-brand the program, materials, and student certificates. For instance, Logos and other materials will be used with mutual consent and according to each institution's brand guidelines.

4. Duration

This collaboration will last for a period of one (1) year, starting from 21 April 2025 to 20 April 2026.

5. Non-binding Agreement

This MoU is not legally binding but reflects the mutual understanding and intention of both parties (CU and LLA) to collaborate in good faith for the betterment of our Indian youth and society.
